## Terms and Conditions of Entry

Work must be the sole and original work of the entrant; it must be an original composition and not a copy of any other work, photograph or reproduction.

The closing date for receipt of all entries by post or email is 30 MARCH 2012.

The competition is open to all artists over the age of 18 after September 2011. Applicants are encouraged to apply online. The application is available to download at [www.benuri.org.uk](http://www.benuri.org.uk) Please e-mail your application with a single high-quality jpeg of no more than 1MB per work. Transparencies/CDs/DVDs can be posted (no slides please) with the printed application form. Do not send original work at this stage. Also please send/email an up-to-date CV.

It is in the artist's interest to ensure that the reproduction of their work is of the highest quality as judges use them to make their preliminary selection.

Artists 24 and over may submit up to three works at a cost of £25/€30/\$40 for each of the first two works or £65/€80/\$100 total for a maximum of three works. Artists aged 18–23 may submit up to three pieces of work for a total cost of £15/€20/\$25 (the cost is lower in support of emerging artists).

Successful applicants will have the opportunity to sell their work whilst it is on display at Ben Uri. Ben Uri will charge a 25% commission on all works sold. Ben Uri reserves the right to acquire the winning work of art.

No artwork may exceed 150 x 150 cms (x 150 cms for objects).

Circa 40 artists will be selected for the shortlist and their work will be exhibited in London during May 2012 and they will be notified of the judges' decision in April. You will be notified on the email address you provide if your application has not been successful. The judges' decision will be final. Those who have been selected must then arrange for transport of their work to: Ben Uri Gallery, 108a Boundary Road, London NW8 0RH.

Artists are responsible for transportation, including any costs, of their work to and from Ben Uri, where the works will be stored until the exhibition. Artists must confirm with Ben Uri the transport arrangements for their work in advance.

Artists are responsible for insurance of their work for the full agreed amount during transit to and from the exhibition. Works must be adequately packed/ wrapped for transport.

Artists **MUST** ensure they select a method of TEMPORARY IMPORT, when arranging transportation of works from overseas.

Works must be delivered between 30th April and 3rd May only. If works arrive after this date there is no guarantee that they will be included in the exhibition.

Works must be collected from Ben Uri on 30th and 31st May. Any work remaining at the gallery after that time will be sent to commercial storage at the artist's expense.

Artists must ensure that their work is secure and ready for hanging/display. The gallery is not responsible for any damage to work during transit to and from the exhibition. Ben Uri will insure all work while it is at Ben Uri.

All works must be clearly labelled with title, artist's name, address, phone number and email. Please provide any specific hanging/installation instructions.

All applications must include an up-to-date CV, an artist's statement and a specific narrative about the work(s).

The artist must own the copyright of any works entered into the competition and, if selected for exhibition, agree for an image of the work to be used for any publicity material relevant to the IJAYA and Ben Uri Gallery.

Failure to observe these conditions will render the entry void.
